1. <u>Description of Real Estate</u>. Seller agrees to sell and convey, and Buyer agrees to purchase, upon the following terms, the Seller's interests in real estate, with all buildings, fixtures, improvements, and appurtenant easements, on East Broadway, Salem, Rockingham County, New Hampshire, known as 115 East Broadway, Tax Map 15, Lot 5818 (the "Real Estate").

2. <u>Accepted Bid Price; Payment Terms</u>. Seller hereby acknowledges receipt of \$10,000.00 from Buyer, as a down payment for the purchase of the Real Estate (the "Initial Down Payment"), Buyer being the highest bidder at the real estate auction, with a bid of \$______ (the "Selling Price").
