- All sales are "AS IS, WHERE IS" and subject to error, omission, deletion, and addition. No warranty either expressed or implied is made by seller or auctioneer regarding condition, quality, purpose, or any other matter.
- Payment must be made in full Saturday, Oct. 18, 2025, by cash, check (accompanied by bank letter stating check will be acceptable for a certain dollar amount), Visa or Master-Card with a 3% convenience fee, before removal of items. Auctioneer at his discretion may accept or reject any form of payment.
